Short Summary
<p>While being based on the EUR Strategy 2024, the proposed Internationalisation Policy 2021-2024 takes into consideration the international developments, new (COVID-related) context and national political climate. It translates the agendas of OCW and the VSNU into the EUR own "Erasmian way" of addressing the new challenges. As international university, in policy period 2021-2024 EUR would like to work along four major themes: <i>innovative education, interdisciplinary research, societal impact and enhanced services on the campus</i>.</p>

<p>This Policy is part of the implementation of Strategy 2024. Internationalisation is one of the focal points of Strategy 2024, this policy framework for internationalisation is a first step towards the realisation of the strategic priorities on the topic of internationalisation.
