Thank you very much for your message and for bringing this concern to our attention.

The UC discussed your email during its meeting on May 6. The UC has addressed this topic on several occasions in the past, both with the Executive Board and with other stakeholders. Each time, the conclusion has remained that strict enforcement of the smoking ban proves to be challenging. For that reason, the university has been exploring alternative, more active solutions to encourage both students and staff to respect the smoking ban as much as possible.

Nevertheless, the UC has decided to bring this matter forward once more in the upcoming consultation meeting with the Executive Board on May 27. Following that meeting, we will provide you with an update on the outcome of the discussion. We appreciate your continued attention to this issue and thank you again for your efforts and your message.
